




#### Fig.1 Ground Emitter Propagation Characteristics

Fig.3 DC Current Gain vs. Collector Current (I)




### Fig.2 Grounded Emitter Output Characteristics




COLLECTOR TO EMITTER VOLTAGE : V<sub>CE</sub> [V]


Fig.4 DC Current Gain vs. Collector Current (II)



# Fig.6 Collector-Emitter Saturation Voltage vs. Collector Current(II)






Fig.8 Gain Bandwith Product vs. Emitter Current







Fig.10 Safe Operating Area
