


Figure 1. Internal schematic diagram





Figure 2. Safe operating area


Figure 3. Derating curve





Figure 6. Collector-emitter saturation voltage

Figure 7. Base-emitter saturation voltage








Figure 8. Base-emitter on voltage





Figure 10. Resistive load switching time

Figure 11. Resistive load switching test circuit


